Thriving Non-Profits is a leadership training program created by non-profit leaders for non-profit leaders. The program helps your organization develop the mindset, culture, and strategies required to integrate new entrepreneurial approaches to achieve financial resilience and greater community impact.





### PROGRAM OVERVIEW

Thriving Non-Profits is a game-changing learning program that walks non-profit organizations through nine entrepreneurial revenue diversification strategies that can create greater financial stability, bring in new resources to support their programs and teams, and increase the impact they have in the community.

The learning content has been informed by the collective participation of 1000s of non-profit leaders, and each module in the program integrates the real-world experience of people who understand the complexities and challenges of the non-profit sector.

Participants graduate with a personalized revenue diversification action plan and a clear strategy for implementation.

Throughout the program, participants have the opportunity to learn alongside like-minded non-profit leaders and gain access to the Thriving Non-Profits Community: a place to share knowledge, find resources, attend live events, and get expert advice from experienced coaches and impact sector experts.



The program is available in two streams: a cohort model with set dates, and a self-paced version for individual learners. Both versions contain the same innovative learning, tools and resources required to create a revenue diversification action plan and implementation strategy.
